Maritime search and rescue is carried out at sea to save sailors and passengers in distress, or the survivors of downed aircraft. The type of agency which carries out maritime search and rescue varies by country; it may variously be the coast guard, navy or voluntary organizations. When a distressed or missing vessel is located, these organizations deploy helicopters, rescue vessels or any other appropriate vessel to return them to land.

In addition, the 1979 INTERNATIONAL CONVENTION ON MARITIME SEARCH AND RESCUE (SAR CONVENTION) obliges State Parties to ‘... ensure that assistance [is] provided to any person in distress at sea ... regardless of the nationality or status of such a person or the circumstances in which that person is found’ (Chapter 2.1.10) and to ‘... provide for their initial medical or other needs, and deliver them to a place of safety’ (Chapter 1.3.2).
